## ELIGIBILITY

- ❖ Instruments: piano, violin, viola, cello, or double bass;
- ❖ Applicants must have the right of abode in the Hong Kong Special Administrative Region;
- ❖ Applicants must be born in 1995 or after;
- ❖ Applicants should be current students at music conservatories/ equivalent institutions, or recent graduates (who have graduated in or after 2023) from music conservatories/ equivalent institutions.

## APPLICATION PROCESS

### STEP 1: To create and upload an unedited audition video on YouTube

**Self-introduction** before the performance:

Applicants shall introduce themselves in English before the performances:

- Applicant's name and 2-3 mins of self-introduction, including your motivations and goals for a career in music and what you see yourself doing in 10 years' time
- Title and composer for each piece in order

**Video Performance:**

- Applicants should make the best effort to send the audition video with a good and clear sound quality; otherwise, bad sound quality may adversely affect the applicant's chances.
- The video should be recorded from only ONE camera without editing. The applicant should be visible, and hands clearly displayed throughout the video. String players should be facing the camera and not away from it.
- If there is piano accompaniment, skip all long tutti passages where the applicant is not playing.
- Applicants are required to present themselves in front of the camera before the performances.
- The video should be uploaded to the applicant's personal YouTube account and set as "Public" or "Unlisted" and NOT as a link to a file.

### STEP 2: To complete and submit an online application

Applicants shall complete and submit an online application and include the following supporting materials.

**Supporting materials include:**

- A **YouTube video** link as in STEP 1;
- A copy of **HKID or documentation of right of abode in Hong Kong**;
- A copy of **student ID or graduation diploma or certificate** from the current or most recent institution;
- **Letter(s) of Recommendation** either from a teacher or a mentor; and
- **Transaction record of the deposit.** Applications are only accepted after a HK\$1,200 deposit is paid. The deposit will be returned to applicants upon the completion of the audition(s).

## Young Artist Audition 2025 - Terms and Conditions of Application

---

This program is only open to the online application. In applying for the Young Artist Audition, applicants must accept and agree to the following terms and conditions, and any ongoing updates to these terms and conditions.

1. Applicants must meet the eligibility requirements set out above.
2. If the applicant does not provide sufficient information, Musicus Society Limited (hereinafter "The Society") may not be able to process his/her application.
3. Personal data provided will be used by the Society for processing any application and will be held for statistics, correspondence, and publicity purposes.
4. The winner will be notified in writing by the Society for the engagement schedule of concerts, rehearsals, and events. Such times may be varied by the Society at its discretion. The winner is required to sign a separate undertaking and must punctually attend assigned engagements in person at all times.
5. The winner shall make himself/herself available for media interviews, press conferences and 'meet the artist' session(s) where reasonably requested, and other events which may be arranged by the Society for publicity and promotional purposes.
6. The Society shall have the right to use any videos, essays, photos, and sound recordings submitted by any applicant or otherwise taken during the project activities participated by the applicants, for non-commercial purposes or for any publicity and promotional purposes of the Society and/or its sponsors, partners, and/or collaborators. The Society shall own all the rights including copyrights of any photograph, audio and videos taken with the successful applicants during the engagement.
7. The Society reserves the rights to determine the final performer roster for all its concerts and outreach events.
8. The Society reserves the right to withdraw the winner's offer or terminate any engagement with the winner should he/she fail to observe the conditions set out by the Society, and the general professional conduct applicable to performing artists worldwide.
9. The content of these activities does not reflect the views of the Government of the Hong Kong Special Administrative Region.
10. All decisions of The Society shall be final and binding on the applicants and cannot be disputed.
